APPLICATION FOR SUBPOENA OF SAMANTHA OLD

TO THE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

Duquesne Light Company (“Duquesne Light” or the “Company”) files this Application for Issuance of Subpoena for the Matter of Christopher Old pursuant to Section 5.421 of the Pennsylvania Public Utility Commission’s (“Commission”) regulations, 52 Pa. Code § 5.421. In support thereof, Duquesne Light submits the following:

1. Duquesne Light Company was served with the Complaint of Christopher Old, Docket C-2025-3054370 (“Complaint”) on April 2, 2025. In his Complaint, Complainant alleges that a Duquesne Light account was fraudulently opened in his name at 3122 Shadeland Avenue, Pittsburgh, Pennsylvania 15212. Complaint at ¶ 4.
2. On April 22, 2025, Duquesne Light Company filed its Answer.
3. On April 29, 2025, a Prehearing Order was issued, scheduling a telephonic hearing for Wednesday, June 18, 2025.
4. On June 11, 2025, the Company submitted proposed exhibits on the Presiding Office and Christopher Old.

5. On June 18, 2025, Complainant called into the telephonic hearing to request a continuance, which was granted.

6. The second telephonic hearing was scheduled for August 27, 2025 per Prehearing Order issued on July 8, 2025.

7. On August 25, 2025, the Complainant contacted the Administrative Law Judge and the Company with a request for another continuance to secure counsel. A Continuance was granted.

8. A third telephonic hearing was scheduled for October 8, 2025.

9. Complainant obtained counsel on Friday, October 3, 2025. The telephonic hearing scheduled for October 8, 2025 was converted to a prehearing conference.

10. A prehearing conference was held on October 8, 2025 in lieu of a telephonic hearing.

11. On October 30, 2025, counsel for Christopher Old submitted an email to Administrative Law Judge Emily DeVoe and Duquesne Light Company alerting of an intention to file a subpoena to obtain a police report from Pittsburgh Police, noting that “attempts to obtain the police report filed by my client with the Pittsburgh Police have been unsuccessful.”

12. A police report has not been submitted as of this date.

Relevance of Testimony of Samantha Old

13. The instant Complaint alleges that an account at 3122 Shadeland Avenue was opened fraudulently in the name of Christopher Old.

14. As of the date of this Answer, Complainant has not submitted a police report regarding the alleged fraud on his account

15. According to internal records of Duquesne Light Company, Samantha Old is the spouse of Christopher Old.

16. Upon information and belief, Duquesne Light Company intends to establish that Samantha Old has opened an account on behalf of herself and Christopher Old.

17. Duquesne Light Company intends to admit two (2) recorded phone calls from Samantha Old. Duquesne Light intends to admit the first call to demonstrate that Samantha Old called the Company to establish service at 3122 Shadeland Avenue in the name of Christopher Old. Duquesne Light intends to admit the second call to demonstrate that Samantha Old identified herself and called to establish service in the name of Christopher Old, on behalf of Christopher Old, at 3122 Shadeland Avenue.

18. The testimony of Samantha Old is required to determine whether service was fraudulently opened in Christopher Old's name.

19. Complainant has not provided any evidence to substantiate his claim that service was fraudulently opened.

WHEREFORE, Duquesne Light Company respectfully requests that this Application for Subpoena be granted. Copies of this Application are being provided as indicated on the Certificate of Service. A proposed Subpoena is attached to this Application.
