RE: Easton Telecom Services, L.L.C., Tariff Advice Letter

Dear Secretary Homsher:

Easton Telecom Services, L.L.C. (“Easton” or “Company”) submits to the Pennsylvania Public Utility Commission (“Commission”) the Company’s Tariff Telephone – PA P.U.C. No. 3, the Company’s competitive local exchange tariff. This Tariff Telephone – PA P.U.C. No. 3 replaces Easton’s Tariff Telephone – PA P.U.C. No. 2 in its entirety.

With this submission, Easton updates its local exchange rates in Pennsylvania. Easton has elected to submit a complete tariff replacement due to the extent of rate amendments resulting from underlying carrier rate amendments in the Commonwealth and to simplify its tariff format.

Easton provides services exclusively to an exceptionally limited number of commercial subscribers in Pennsylvania. The Company’s services are generally provided under service agreements, which set forth the rates, terms, and conditions of service. On September 27, 2023, Easton requested cancellation of its Pennsylvania *interexchange* services tariff, Tariff Telephone-Pa. P.U.C. No. 1, pursuant to 66 Pa. C.S. § 3018(b). Easton’s service agreements obviate the need to maintain tariffs generally, to the extent that Easton may avail itself of retail service deregulation.

Subscribers have been notified of changes to rates, terms, and conditions through direct personal contact from customer service representatives and through billing inserts or notices.

Pursuant to [52 Pa. Code § 53.58\(d\)](#), the Company has posted its proposed tariff on the Company's web site, <http://www.eastontel.com/customer-resources> and will post the final version of its tariff upon Commission approval.
