Participating in a Telephonic Public Input Hearing: To testify at a telephonic public input hearing, you are encouraged to pre-register by **4 p.m. on Thursday, December 11, 2025**. Pre-registration is not required to testify at any of the in-person public input hearings.

PRE-REGISTRATION INFORMATION: Whether pre-registering by email or telephone, in both cases, provide the following information:

- (1) your first and last name,
- (2) the phone number you will be using to call into the public input hearing,
- (3) a phone number where you can be reached prior to the hearing if we need to contact you, and
- (4) your email address, if you have one.

Failure to pre-register for a telephonic public input hearing could result in you not being called to testify by the PUC Judge.

NEED ASSISTANCE WITH PRE-REGISTRATION? If you need assistance pre-registering to testify, you may have someone register for you, but they will need to provide all the information listed above. Additionally, if more than one person in your household would like to testify, one person may pre-register for other individuals in the same household by providing the PUC Judges' Legal Assistant with the above-listed information for each individual.
