To Whom It May Concern:

The Order entered October 15, 2025, stated that if the owed assessment and civil penalty of \$5,558 was not paid within thirty (30) days of the entry date of the Order, the Certificates of Public Convenience held by C&J Well Services Inc T/A C&J Energy Services at Application Docket No. A-2015-2498472 would be cancelled without further action by this Commission.

To date, more than thirty days later, the respondent has not paid their owed assessment and civil penalty in full; therefore, the Certificate of Public Convenience held by C&J Well Services Inc T/A C&J Energy Services at Application Docket No. A-2015-2498472 has been cancelled. The Commission has also dismissed the proceeding at Docket No. M-2024-3047909.

Furthermore, this Commission will request the Pennsylvania Department of Transportation to put an administrative hold on the Respondent's vehicle registrations. Respondent will **NOT** be able to register any new vehicles or renew any existing vehicle registrations until all past due assessments are paid, all past due fines are paid, all insurance filings are up to date, and it holds an active Certificate of Public Convenience issued by this Commission.

Respondent is hereby notified to cease and desist from further violations of the Public Utility Code, 66 Pa. C.S. §§1.1 et seq., and the regulations of the Commission, 52 Pa. Code §§1.1 et seq. In view of the **cancellation of respondent's Certificates of Public Convenience**, it is specifically prohibited from rendering service as a common carrier by motor vehicle in intrastate commerce in the Commonwealth of Pennsylvania.
