- A. Hiring Standards for drivers- There are no age restrictions on but we do require drivers have 10-15 years of driving experience to help keep insurance cost reasonable.
- B. We will conduct criminal background checks through a background check on Pennsylvania United Judicial System website along with the services of a third party company (backgroundchecks.com). This will be completed every 6 months. Disqualifying factors in hiring would be but not limited to Felony, (Murder, rape burglary) DUI of drugs or Alcohol, sex offenders. Records of these background checks will be kept in our company file cabinet in company office under lock and key accessible only by company ownership.
- C. Conducting Driver license/history checks – We will pull the applicants driving record from the PA Department of Transportation before hiring and every year after date hired. All records will be kept in our company file cabinet in company office under lock and key accessible only by company ownership.

2 A. Weekly Vehicle inspections will be conducted by the company on every vehicle. This will include but not limited to test driving all vehicles to make sure they are in working order, along with inspection of tire ware, lights & turn signal operation, body damage ect. All drivers are required to report any issues with the vehicle after each usage which will be fixed immediately.

B. Maintenance will be performed such as oil change and tire rotation every 6,000 miles. At that time our mechanic will check break wear along with a safety check on all vehicle functions. A full maintenance log on each vehicle will be kept in the company office show date, any maintenance done on the vehicle and mileage along with copy of invoice for that work. Attached is a copy of Maintenance report we will use for each vehicle.

3. Vehicles will be inspected yearly as required by PennDOT. We will also have a semi-annual DOT inspection report completed on each vehicle and kept in each vehicle file.
