Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, effective November 24th, 2025, for Move Solutions, LLC, t/a College Hunks Hauling Junk and Moving of Levittown (PA PUC Certificate #A-8923980) in Trevose PA.

The attached pages are 734th Revised Page 2, 35th Revised Page 2-D, and 3rd Revised Page 71-D. This is a **REDUCTION** in local hourly rates for Driver, Vehicle & 1 Helper and Additional Men. All other rates for this carrier remain the same.

0 - 20 miles	1 hour
21 - 40 miles	1 1/2 hours

For mileage in excess of 40 miles, a travel time charge of 1/2 hour will be assessed for each additional 20 miles.
