**EXCEPTIONS OF BHAVESH PATEL TO INITIAL DECISION OF ADMINISTRATIVE  
LAW JUDGE CHRISTOPHER P. PELL DATED OCTOBER 31, 2025**

**I. EXCEPTION NO. 1**

Bhavesh Patel (“Patel”) files an exception to the Finding of Fact No. 8. The reasons for this exception are that the evidence of record does not support a finding that Aaron Anderson is the partner of Bhavesh Patel. The relationship between Patel’s company and Mr. Anderson is that of franchisor/franchisee which is a different relationship than a partnership.

**II. EXCEPTION NO. 2**

Patel files an exception to the finding on Page 8 of the Initial Decision that Patel is in business with Aaron Anderson as the record demonstrates that the relationship between Patel’s company and Mr. Anderson is that of franchisor/franchisee.

**III. EXCEPTION NO. 3**

Patel files an exception to the finding that Patel and/or his company are responsible for the accrued balance at the service address and that Patel was not entitled to a refund of the amount paid to have the service restored since this finding appears to be based on the erroneous

conclusion that Patel and Anderson are partners and that this business relationship somehow attributes actions of Anderson and/or actions of the prior business located at the subject premises, namely Brunchaholics, to Patel.
