Ark Life Services, LLC respectfully submits this correspondence in response to the Data Request issued regarding the above-referenced application.

Regarding Item #1:

Ark Life acknowledges that it currently holds authority under Certificate No. A-2025-3053956 to operate paratransit service within Philadelphia and Delaware Counties. The present application seeks to expand service solely into Montgomery County, Pennsylvania.

At the time of the original filing, Ark Life voluntarily filed a restricted amendment removing Montgomery County in order to resolve a protest and facilitate approval of its initial authority. Since that time, the company has successfully launched operations, maintained regulatory compliance, and developed the operational infrastructure necessary to support responsible expansion.

In recent months, Ark Life has received a disproportionate number of transportation requests and inquiries originating from Montgomery County in comparison to requests for transportation originating from Delaware and Philadelphia counties. These developments demonstrate a clear public need for additional, dependable paratransit service in that region.

Accordingly, Ark Life respectfully requests the Commission's consideration of this application for authority in Montgomery County based on these changed circumstances and documented community demand.

I, Rosemary Oluwo, hereby state that the facts above set forth are true and correct to the best of my knowledge, information and belief, and that I expect to be able to prove the same at a hearing held in this matter. I understand that the statements herein are made subject to the penalties of 18 Pa.C.S. § 4904 (relating to unsworn falsification to authorities).

10. Describe the service area proposed by this application.

To transport, as a common carrier, by motor vehicle, persons in paratransit service, from points between Montgomery County to points in Pennsylvania, and return.

Examples:

- *To transport people whose personal convictions prevent them from owning or operating motor vehicles from points in Lancaster County to points in PA, and return.*
- *To transport people from the city and county of Philadelphia to correctional facilities in PA, and return.*
- *To transport people in wheelchair and stretcher vans from points in the city of Pittsburgh to points in Allegheny County, and return.*
- *To transport people between points in Northumberland County.*

11. Certification:

Applicant certifies that it is not now engaged in unauthorized intrastate transportation for compensation between points in Pennsylvania and will not engage in said transportation unless and until authorization is received from the Pennsylvania Public Utility Commission.

Applicant further certifies that it understands the requirements of the Pennsylvania Public Utility Commission, especially as they relate to safety and insurance and that it may be subject to civil penalties, suspension or cancellation of the Certificate for failure to comply with Commission requirements.

Applicant further certifies that it understands that it is subject to an annual assessment based upon its reported gross Pennsylvania intrastate revenues; said assessment to help defray expenses incurred in regulating Motor Common Carriers of Persons in Paratransit Service; and acknowledges that failure to report revenue and pay its annual assessment may result in civil penalties, suspension or cancellation of the certificate.
