**REPLY EXCEPTIONS OF PECO ENERGY COMPANY**

PECO Energy Company (“PECO Energy”) hereby replies to the Exceptions filed by DAVID DETLEFSEN (“Complainant”) on October 29, 2025.<sup>1</sup> On April 5, 2024, PECO Energy was served with a formal complaint filed by the Complainant against PECO Energy. In the formal Complaint, the Complainant stated that he had not received monthly billing since November 2023. On April 23, 2024, PECO Energy filed an Answer with New Matter to the Complaint denying all conclusions of law and material allegations of the Complaint and advised that PECO was actively investigating the Complainant’s concerns.

On June 3, 2025, Deputy Chief Administrative Law Judge Pell (ALJ Pell) issued a hearing Notice directing the parties to appear for a hearing on August 4, 2025 at 10:00 a.m. On October 28, 2025, ALJ issued an Initial Decision dismissing the Complainant’s Complaint for failure to appear for the hearing.

On October 29, 2025, the Complainant filed Exceptions to the Initial Decision. In his writing, the Complainant states that it was his understanding that there was a standing Continuance request by PECO before the Public Utility Commission until his Complaint was resolved with PECO. While PECO disputes that a standing request existed to file Continuance requests with the

Public Utility Commission<sup>2</sup>, PECO files the instant Reply Exceptions and states that it does not object to the Complainant's request to reopen the Complaint.
