

NOTE 2 - Hourly rates (Column 2) computed in half-hour periods; fractions of one-half hour considered as one-half hour.

NOTE 3 - Minimum Transportation Charge: Any Day, Any Hour: 3 hours at rates named in Column 2 plus applicable travel charge.
