CONTINUANCES. You may request a continuance of the prehearing conference if you have a good reason. All continuances will be granted only for good cause. To request a continuance, you must submit a written request (a “motion”) at least five (5) days before the prehearing conference. Your motion should include: 1) The case name, number, and prehearing conference date; 2) The reason for the request; and 3) Whether the other party agrees (or if you do not know).

REPRESENTATION. If you are an individual, you may represent yourself or you may have an attorney represent you. All others, including a partnership, corporation, limited liability company, trust, association, or governmental agency or subdivision, must be represented by an attorney licensed to practice law in Pennsylvania, or admitted *pro hac vice*. Only an attorney may represent someone else.

ACCOMMODATION. Any party who needs accommodation for a disability in order to participate in this hearing process may request one. Please call the OALJ scheduling office at least five (5) business days prior to your prehearing conference to submit your request.

If you require an interpreter to participate in the prehearing conference, please call the scheduling office at least ten (10) business days prior to your prehearing conference to submit your request.
