Application of Loop Telcom Pennsylvania, LLC for approval of the alteration of the crossing where State Route 2007 (Laurel Run Road) crosses, above grade, track of Reading Blue Mountain & Northern Railroad Company (DOT 361 418 Y) by the installation of an aerial fiber optic wire, in the Borough of Laurel Run, Luzerne County

To Whom It May Concern:

By Secretarial Letter dated April 2, 2024, Loop Telcom Pennsylvania, LLC was directed to complete the subject crossing alteration on or before March 31, 2025.

By letter petition received by the Commission on October 21, 2025, a representative of Loop Telcom Pennsylvania, LLC requests an extension of time to October 1, 2026, to complete the alteration of the subject crossing due to supply chain and permitting delays.

We have carefully reviewed the record in this proceeding and will grant Loop Telcom Pennsylvania, LLC an extension of time to October 1, 2026, to complete the alteration of the above captioned crossing.

This Commission issues this Secretarial Letter in accordance with Section 2702 of the Public Utility Code.

THEREFORE:

The letter petition of Loop Telcom Pennsylvania, LLC received by the Commission on October 21, 2025, requesting an extension of time, be and is hereby granted to the extent herein directed:

1. Paragraph 8 of our Secretarial Letter dated April 2, 2024, which reads as follows, to wit:

“8. The alteration of the crossing be completed on or before March 31, 2025, and that on or before said date Loop Telecom Pennsylvania, Inc report in writing the date of actual completion of the work to this Commission and certify to the parties of record and this Commission that the work has been satisfactorily completed in accordance with the approved plan and this Secretarial Letter.”

be and is hereby modified to read:

8. The alteration of the crossing be completed on or before October 1, 2026, and that on or before said date Loop Telecom Pennsylvania, Inc report in writing the date of actual completion of the work to this Commission and certify to the parties of record and this Commission that the work has been satisfactorily completed in accordance with the approved plan and this Secretarial Letter.

2. In all respects not inconsistent herewith, our Secretarial Letter dated April 2, 2024, remains in full force and effect.

The Parties are reminded that failure to comply with this or any Order or Secretarial Letter in this proceeding may result in an enforcement action seeking civil penalties and/or other sanctions pursuant to 66 Pa. C.S. § 3301.



If your filing contains confidential material, you are required to file by overnight delivery to ensure the timely filing of your submission. These must be submitted to the Secretary by overnight delivery, priority, or certified mail to allow tracking of your filing.

If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §§ 1.31 and 5.44, file a Petition for Reconsideration from Staff Action (Petition) with the Commission within twenty (20) days of the date of this letter. The Petition shall be eFiled with the Secretary of the Commission or sent to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120, and must be filed within twenty (20) days, or if no timely request is made, the action will be deemed to be a final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request; (2) the case docket number (it is provided for you at the top right-hand corner of this letter); (3) the party on whose behalf the petition is made; (4) a Certificate of Service on the other parties of record; and (5) a Verification with original signature in accordance with 52 Pa. Code § 1.36.
