- 1) The name and address of the petitioner is Gettysburg & Northern Railroad, 750 Mummasburg Road, Gettysburg, PA 17325.
- 2) By secretarial Letter dated December 15, 2023, later modified by a letter petition for an extension of time, the Commission directed that, "The alteration of the crossing be completed on or before December 31, 2025..."
- 3) This project includes federal, state and private funding and as such the project has taken longer to develop than originally anticipated.
- 4) Accordingly, the Railroad respectfully requests an extension of time to complete the alterations to the subject crossing to May 31, 2026.

Wherefore, the Gettysburg & Northern Railroad requests that the Commission's Secretarial Letter in this matter be modified consistent with this Petition.


