A Pennsylvania Limited Liability Company

**ARTICLE I
Company Formation**

1.1 **FORMATION.** The Member formed as a Limited Liability Company subject to the provisions of The Pennsylvania Limited Liability Company Law of 1994, 15 Pa.C.S. § 8901, et seq (“Act”). A Certificate of Organization was drafted and was filed with the Pennsylvania Department of State on November 4, 2025.

1.2 **NAME.** The name of the Company is TM HAULING LLC (“Company”).

1.3 **REGISTERED AGENT.** The Member has not appointed a registered agent to act on behalf of the Company.

1.4 **TERM.** The Company shall continue for a perpetual period unless,

(a) The Member votes for dissolution; or

(b) Any event which makes it unlawful for the business of the Company to be carried on by the Member; or

(c) Any other event causing dissolution of this Limited Liability Company under the laws of the State of Pennsylvania.

1.5 **BUSINESS PURPOSE.** The Company was formed for the purpose of providing hauling services and to engage in any and all activities necessary, convenient, desirable, or incidental to the foregoing, and any other business that is legal.
