

Susan Lloyd v. PPL Electric Utilities Corporation

LLOYDS REPLY TO PPL ANSWER TO LLOYDS COMPLAINT AND PPL NEW
MATTER AND PPL PRELIMINARY OBJECTIONS

1. Lloyd filed this matter as PPL is now trying to terminate Lloyds services as Lloyd refuses to pay bill from Dec 202/Jan 2023 as Lloyd does not owe the money so res judicate does not apply as the termination is a new matter in this case.

2. Ppl spoliated evidence in this matter and even blocked LLOYD from obtaining any bills which apply to this matter and at first hearing with the PUC admitted to destroying evidence so Lloyd is entitled to summary judgment as an adverse inference of wrong doing applies to PPL.

3. Lloyd has every intention on pursuing this matter in court against PPL and PUC if this bill is not deleted.

4. Common sense should have prevailed in this matter a long time ago

5. Once again PPL is out of their minds to believe that any one person living in a one bedroom brand new energy efficient apartment who does not use heat can use almost 500.00 a month in electric

6. Lloyd asserts that even if someone living in a 800 sq foot apt used heat, the bill would still not even come close to 500.00 and would be around 150.00

6. Amazingly enough, the very next month, Lloyds bill was 160 and has never been over 160 for the past 3 years.

6. PPL is fabricating evidence to try to collect from Lloyd after they paid 16 million dollars in fines as a direct result of their fraudulent billing thousands of people for the same time frame

7. As part of their 16 million dollar settlement, PPL agreed to not collect on these bills and yet now they have threatened to terminate Lloyds services as a direct result.

8. PPL sent Lloyd a termination notice after 3 years as they know the law only allows them to terminate services for bills less than 4 years old so this was a scare tactic to try to get Lloyd to pay

9. Lloyd is NEVER paying this bill as Lloyd does not owe this money

10. Lloyd is also low income and has health conditions including the use of oxygen and CPAP which requires electric.

11. PPL knows if they shut off Lloyds electric they have a potential to kill Lloyd but they dont care.

12. PPL is so greedy for the money so they can recoup on their 16 million dollars in fines they had to pay for their fraud

13. Lloyd has sent the PUC an intent to sue notice if this bill is not deleted from Lloyds account

14. The PUC is allowing PPL to lie and fraudulently attempt to collect money for bills Lloyd does not owe

15. Lloyd asserts PPL even refused to come to Lloyds apartment when she complained about their egregious bill.

16. PPL had no desire to find the truth of this matter.

17. PPL wants to continue to tell false statements and destroy evidence in this matter

18. PPL admits that the Dec 2022/Jan 2023 bill is the only bill Lloyd has refused to pay

19. PPL is trying to collect this debt now as they know they only have 4 years to terminate for their fraudulent billing so they have devised a plan to try to force Lloyd to pay their fraudulent bill.

20. It is egregious after PPL paid 16 million dollars in fines for trying to steal money from other customers that they now have continued to try to steal money from Lloyd

21. It is egregious that PPL is allowed to steal money from disabled people such as Lloyd and are discriminating against Lloyd

22. Again, if this bill is not deleted, Lloyd has every intention of suing PPL, PUC and Post and Schell in court for fraud, abuse of process, violation of due process and other causes of action

23. It is the pUC responsibility to do the right thing but so far they have allowed PPl to commit fraud and destroy evidence

24. That amounts to a 1985 conspiracy as PPl and PUC has conspired together to steal money from Lloyd and to terminate Lloyds electric

25. PUC knows there is absolutely no way an 800 square foot apt used 500.00 worth of electric in one month when Lloyd DOES NOT EVEN USE HEAT

26. PUC has allowed PPL to destroy evidence in this matter and then conspired with PPL to steal money from Lloyd

27. PUC is not immune as they have taken Lloyds property (her money) (her electric) (her bills) and violated Lloyds due process rights by allowing PPl to destroy evidence in this matter and by allowing Post and Schell and PPl to lie in this matter

28. A govt agency is not immune when they commit fraud.

Either delete my bill or I will sue you in court

Since the PUC feels that PPL is allowed to steal money, they can pay Lloyds bill. Once again, Lloyd is NEVER paying this bill and if PPL moves to shut off Lloyds electric, Lloyd will also be suing for personal injury and PPL and PUC will be held responsible for wrongful death by Lloyds family if Lloyd dies as a result.

It is egregious and despicable that PUC is allowing PPL to commit fraud and destroy evidence

Post and schell could have used common sense and realized there is no way in hell Lloyd used 500.00 worth of electric in one month

But it appears they conspired with PPL to steal money from customers also and it appears they are getting a percentage of the recovered funds from the people dumb enough to pay PPLs fraud. That is a conspiracy to steal property (money) from people. Along with their conspiracy with the PUC, post and schell, PPL and PUC are not immune from any lawsuit.
