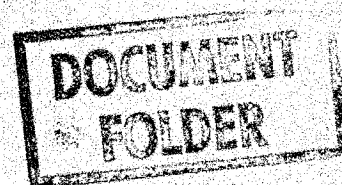
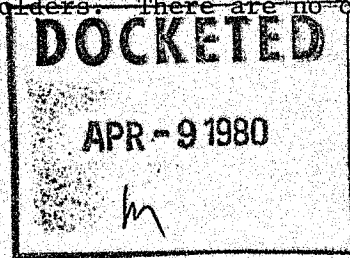
BY THE COMMISSION:

By this application filed on January 23, 1974 and supplemented in March 1976 and December, 1979, Wonderview Water, Inc., Bloomsburg, seeks a certificate of public convenience pursuant to Section 1101 of the Public Utility Code, 66 Pa. C.S. §1101, evidencing Commission approval of the right of applicant to begin to furnish water service to the public in portions of Catawissa and Main Townships, Columbia County, as described by courses and distances and shown on a map attached to the application.

Proofs of service and publication were submitted by applicant. No protests were filed and no hearing was held. No motions or petitions have been filed in this proceeding.

Applicant was incorporated under the Business Corporation Law on December 12, 1966 to furnish water service in the Wonderview Development in Catawissa and Main Townships, Columbia County. Water service has been furnished in the development since 1967. Service is presently furnished to approximately 40 residences and will be furnished to a maximum of 140 residences when the development is completed.

Applicant's water supply facilities include two wells with yields of 15 and 28 gallons per minute, a 65,000-gallon reservoir, 3,200 feet of six-inch main, 3,700 feet of two and three-inch main, 4,000 feet of 1 1/2-inch main, 3,300 feet of one-inch main, four fire hydrants, booster pumps and chlorination facilities. The depreciated cost of the present water facilities is stated to be \$73,361.00 which was financed by the stockholders. There are no outstanding notes, bonds or mortgages.



Pennsylvania Department of Environmental Resources for the operation of its water supply facilities.


Upon full consideration of all matters of record, we find that approval of this application is necessary for the service and convenience of the public; THEREFORE,

That a certificate of public convenience be issued pursuant to Section 1101 of the Public Utility Code authorizing applicant to begin to furnish water service to the public in portions of Main and Catawissa Townships, Columbia County, as described by courses and distances and shown on a map submitted with the application.
