1. By notice dated October 27, 2025, the Commission scheduled a hearing in this matter for Tuesday, December 16, 2025 at 10:00 a.m., before Administrative Law Judge Barbara Shadie Nause.
2. Pursuant to 52 Pa. Code §5.231(a) and the Prehearing Order issued in this matter, PGW is working with the Complainant to reach a resolution in this matter.
3. The parties are actively discussing settling this matter; however, the parties have not yet reached an agreement.
4. PGW and the Complainant need additional time to attempt to resolve this matter as the Complainant has requested a call back, however PGW has had some difficulty reaching her.
