To whom it may concern:

By Secretarial Letter dated December 1, 2025, the Commission dismissed the application of **Shuttlebee Dispatch Solutions Inc** at Case Docket No. A-2025-3056496, for failure to comply with the filing of a surety bond.

This Commission has the power to rescind a Secretarial Letter in light of newly discovered evidence or a change of circumstances which justify reconsideration. The surety bond was filed timely; therefore, it has been determined that the Secretarial Letter of December 1, 2025 dismissing the application of **Shuttlebee Dispatch Solutions Inc**, shall be rescinded.

The number on the license, which is also the first A# at the top of this page, is the PA P.U.C. No. which should be used for identification markings on the vehicles.


