**INTERIM ORDER  
REQUIRING REPRESENTATION**

On October 14, 2025, John Fulton (Complainant) filed a formal complaint against CNX Resources Corporation (CNX). The Commission’s docket notes that a copy of the complaint was served on CNX on October 24, 2025. To date, no answer has been filed.

By hearing notice dated December 8, 2025, this matter was assigned to me and scheduled for a telephonic hearing on January 29, 2026. That notice advised the parties “if you are a partnership, limited liability company, corporation, trust, association, or governmental agency or subdivision, you must have an attorney licensed to practice law in the Commonwealth of Pennsylvania . . . represent you in this proceeding.”

The Commission’s regulations provide that only an individual may represent themselves.<sup>1</sup> Accordingly, in order to participate in these proceedings, CNX, a corporation, must be represented by counsel licensed to practice law in the Commonwealth.<sup>2</sup>

THEREFORE

IT IS ORDERED:

1. That CNX Resources Corporation. is directed to cause an attorney licensed to practice law in the Commonwealth of Pennsylvania in accordance with 52 Pa.Code §§ 1.21-1.25, on or before **Monday, January 6, 2026**.

2. That in the event that no attorney enters an appearance on behalf of CNX Resources Corporation, the Complainant may present testimony and exhibits. CNX Resources Corporation will not be permitted to offer testimony or exhibits in its defense.
