**GRANTING PENNSYLVANIA DEPARTMENT OF TRANSPORTATION'S FIRST**  
**REQUEST FOR CONTINUANCE OF PREHEARING CONFERENCE**

On October 23, 2025, a Prehearing Conference Notice was issued scheduling a prehearing conference in this proceeding for December 17, 2025, at 10:00 a.m.

On October 30, 2025, a Prehearing Conference Order was issued reminding the parties of the date and time for the prehearing conference and setting forth additional requirements.

On December 9, 2025, the Pennsylvania Department of Transportation (“PennDOT”) filed a Request for Continuance of the prehearing conference for approximately 60 days. The request indicated that Norfolk Southern Railroad concurred with the continuance request and that Capital Region Water had not indicated its stance.

Accordingly, PennDOT’s request to continue the prehearing conference will be granted.
