Flat Rates – For all loaded miles from the point of pickup to point of drop-off (one way)

WEEKDAY AND WEEKEND DAYS

12:01 AM to 11:59 PM

AMBULATORY PASSENGERS: \$30.00 Flat Rate 0-10 miles.

PARALIFT PASSENGERS: \$40.00 Flat Rate 0-10 miles.

HOLIDAYS

12:01 AM to 11:59 PM

AMBULATORY PASSENGERS: \$40.00 Flat Rate 0-10 miles.

PARALIFT PASSENGERS: \$50.00 Flat Rate 0-10 miles.

Ambulatory Mileage Rate: \$1.50 per mile, or any fraction thereof, applies in addition to the Flat Rate stated above on all loaded miles, after the first ten (10) miles, from the point of pick-up to the final destination.

Paralift Mileage Rate: \$2.00 per mile, or any fraction thereof, applies in addition to the Flat Rate stated above on all loaded miles, after the first ten (10) miles, from the point of pick-up to the final destination.

Waiting Time At Origin: After the first twenty (20) minutes of free time the passenger will be charged at the rate of \$10.00 for every fifteen (15) minute increment, or any fraction thereof.

Waiting Time During Trip: If the driver is requested to wait for a customer at the destination or during a trip, there will be an additional waiting time charge of \$10.00 for every fifteen (15) minute increment, or any fraction thereof.
