My client, Applicant Humane Care Transportation Service LLC (“Humane Care”), respectfully requests a continuance of the hearing currently scheduled to take place on December 17, 2025. In accordance with Administrative Law Judge Nause’s October 31, 2025 Order, this request is made at least five (5) days in advance of the hearing. The contesting parties—Bux-Mont Transportation, Inc., Easton Coach Company, Suburban Transit Network, Inc., and Tri County Transit Service, Inc.—have consented to this extension.

Good cause exists for this continuance. The contesting parties and Humane Care are actively engaged in discussions regarding a possible resolution of this dispute. Due to year-end schedules and availability constraints, the parties will be unable to meet until at least the new year and require adequate time thereafter to conclude their negotiations and finalize any potential agreement. A continuance would promote judicial economy by potentially avoiding the need for a hearing entirely. Should settlement discussions prove unsuccessful, the parties will be prepared to proceed with a hearing.

Accordingly, Humane Care respectfully requests that the hearing be continued until April 1, 2026, or such other date as the Commission deems appropriate.
