To Whom It May Concern:

The purpose of this Letter is to advise you that your Application, Docket No. A-2025-3058211 has been **DENIED** by the Pennsylvania Public Utility Commission (Commission). The Commission has determined that a Certificate of Public Convenience **WILL NOT BE GRANTED** for the following reason(s):

• **Failure to establish fitness to operate:**

On November 4, 2025, the applicant was issued a detailed 10-day data request seeking an acceptable description of territory, clarification of the intended clientele, fully responsive descriptions concerning the applicant's facilities, the submission of compliant hiring/safety policies, information related to the number of vehicles and drivers, expanded information on vehicle/maintenance policies, insurance policy/quote information, and verifiable evidence to substantiate the financial position stated in the application. The applicant was notified of the specific issues to address and was provided with multiple examples of acceptable evidence to support its financial position.

On November 14, 2025, the applicant submitted a partial response which addressed a portion of the data request's concerns but was incomplete. The applicant's response lacked a full disclosure on its proposed insurance coverage/terms, lacked evidence supporting the applicant's financial position, and lacked evidence of vehicle equipment ownership. The application was held from further processing to afford the applicant the full benefit of the full provided filing window; however no additional evidence was submitted for review.

To date, at least 30 days removed from the Commission's initial request for supporting evidence, the applicant has failed to provide evidence to determine its fitness to operate. Absent the

requested evidence of financial fitness and equipment ownership, the Commission is unable to determine the applicant's fitness to provide safe, efficient, and reasonable transportation.

For these reasons the application remains DISMISSED and DENIED

APPEAL RIGHTS

ALL Parties to proceedings pending before the Commission must open and use an e-filing account through the Commission's website, OR you may submit your filing by overnight delivery. If a filing contains confidential or proprietary material, the filing is required to be submitted by overnight delivery.

If you disagree with this determination, you may send a Petition for Reconsideration of Staff Action to: Secretary, Pennsylvania Public Utility Commission, 400 North Street, Harrisburg, PA 17120. Such a Petition is a written statement asking the Commission to change its determination.

The Petition must be filed with the Commission within twenty (20) days of the date of this letter. If no timely request for reconsideration is made, this action will be deemed to be the final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request, (2) the case docket number(s) (they are provided for you at the top right hand corner of this letter), (3) the name of the person on whose behalf the petition is made, (4) copies of relevant documentation, and (5) a verification with original signature. See 52 Pa. Code §§-1.31 and 5.44.


