**ORDER REASSIGNING APPLICATION**

On August 29, 2025, Community Connection Transportation, LLC (Applicant or Community Connection) filed an application for the right to begin to transport seniors (limited to seniors ages 65 and older), by motor vehicle, in Paratransit service, between points in the counties of Bucks, Chester, Delaware, Montgomery and the city and county of Philadelphia. The Commission caused notice of this application to be published in the October 25, 2025, *Pennsylvania Bulletin* at 55 Pa.B. 7482, specifying a deadline of November 10, 2025, for filing protests.

On November 10, 2025, Bucks County Transport, Inc., Bux-Mont Transportation, Inc., Easton Coach Company, Suburban Transit Network, Inc., and Tri County Transit Service, Inc. (Joint Protestants) filed a Joint Protest, through its counsel, Tanya C. Leshko, Esquire.

Via Hearing Notice dated November 17, 2025, an initial in person hearing on the application was scheduled for Monday, December 15, 2025, at 10:00 a.m. and the matter was assigned to me. I issued a Prehearing Order on November 19, 2025.

On December 3, 2025, Joint Protestants and Applicant filed a Restrictive Amendment with the Commission. Related to the Protest filed in this matter, the parties filed the following Restrictive Amendment and Stipulation:
