RE: TUS Data Request Addressed to Public Utilities Distributing Natural Gas Concerning Plastic Pipe Data – 2025

To: All Natural Gas Public Utilities

The Pennsylvania Public Utility Commission (Commission) is charged with ensuring that utilities maintain adequate, efficient, safe, and reasonable service and facilities. 66 Pa.C.S. § 1501. Pursuant to its authority under 66 Pa.C.S. § 504, the Commission is requesting information from each jurisdictional public utility that distributes natural gas, including natural gas distribution companies (NGDC) and small natural gas distribution utilities, in order to properly evaluate the reliability and safety of natural gas distribution infrastructure. Pursuant to Commission Order entered September 11, 2025, at Docket No. M-2024-3050313, the Bureau of Technical Utility Services (TUS) is seeking information from each Natural Gas Public Utility in Pennsylvania regarding plastic components within their distribution systems.

Please compile a catalog of all plastic pipelines and other plastic components contained within your utility's distribution system. The catalog should include quantities of each component (footage in the case of pipelines, number/quantity in the case of other components), brand of the component, and age. We realize this may require multiple different listings or catalogs to provide the requested information.

In the event that you are unable to provide an accurate catalog as described above, please provide a plan to identify and catalog the amount and type of plastic components within your distribution system, and also provide an explanation of how your utility will differentiate between older, at-risk plastic components and newer ones in your DIMP, and Commission-approved LTIIP if you have one.

Please provide your response to the Secretary of the Commission at the address listed below **within thirty (30) business days** from the date of this letter. All documents requiring notary stamps must have original signatures. The Commission strongly encourages submission through eFiling with the Secretary of the Commission by opening an eFiling account through the Commission website and accepting eservice at <https://efiling.puc.pa.gov>. The Commission is accepting all public documents through our eFiling system at this time.

If your filing contains confidential material, you are required to either file by overnight delivery or submit it to the Secretary's Share Point File system to ensure the timely filing of your submission. Filers should contact the Secretary's Bureau in advance to gain access to the Share

Point File system. Make sure to reference the Docket Number listed above when filing your response. The overnight address for hard-copy or confidential responses is:
