Re: Application of *Yanes Transport Services LLC* for Paratransit authority, 33 Waverly Road, Havertown, Delaware County, Pennsylvania 19083. (484) 682-6887.

To whom it may concern:

The purpose of this Letter is to advise you that your application for Paratransit authority at Docket No. A-2025-3058793 has been **DENIED** by the Pennsylvania Public Utility Commission (Commission). The Commission has determined that a Certificate of Public Convenience shall not be granted for the following reason(s):

On October 28, 2025, the application of Yanes Transport Services LLC was accepted by the Commission of consideration for Paratransit service. Financial information presented by the applicant, Yanes Transport Services LLC, lacked adequate financial fitness to render safe, efficient, and reasonable transportation. On October 29, 2025, a data request was served giving the applicant another opportunity to adequately fund the LLC, asking to do so prior to submitting their response. The applicant was encouraged to consult an attorney or financial expert familiar with regulated Motor Carrier proceedings in preparation for this required information.

The response included a bank statement that was not in the name of the applicant, Yanes Transport Services LLC, as requested and showed less cash on hand. Personal income can only be analyzed as supporting information.

The record demonstrates there is a significant lack of the necessary financial liquidity that will be required to acquire, maintain, replace, and insure a vehicle for the proposed service. At this time, the applicant Yanes Transport Services, LLC, has failed to fund a business account or at the least has failed to provide the requested evidence of such funding. We encourage you to reapply when the business is fully funded.

For this reason(s), your application is **DENIED** and **DISMISSED**.

APPEAL RIGHTS

If you disagree with this determination, you may send a Petition for Reconsideration from Staff Action (Petition) to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120. Such a Petition is a written statement asking the Commission to change its determination.

ALL Parties to proceedings pending before the Commission are advised to open and use an e-filing account through the Commission's website, OR you may submit your filing by mail. If a filing contains confidential or proprietary material, the filing is required to be submitted by mail.

The Petition must be filed with the Commission within twenty (20) days of the date of this letter. If no timely request for reconsideration is made, this action will be deemed to be the final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request, (2) the case docket number(s) (they are provided for you at the top right-hand corner of this letter), (3) the name of the person on whose behalf the petition is made, (4) copies of relevant documentation, and (5) a verification with original signature. *See* 52 Pa. Code §§1.31 and 5.44. Below is a sample Verification:
