PREHEARING ORDER #2

On November 5, 2025, a Prehearing Conference was held in this matter. During the Prehearing Conference, the active parties adopted the following litigation schedule:

The active parties also discussed scheduling four in-person public input hearings and two telephonic public input hearings. The OCA requested that, should any public input hearings be scheduled on or after December 17, 2025, all parties be given the opportunity to provide Supplemental Direct Testimony to address exclusively the issue of the public input hearings in testimony.¹

By In-Person & Telephonic Public Input Hearings Notice issued on November 17, 2025, the following in-person public input hearings were scheduled: December 8, 2025, in Scranton, PA; December 9, 2025, in Catasauqua, PA; December 10, 2025, in Harrisburg, PA; and December 11, 2025, in Lancaster, PA. Additionally, two telephonic public input hearings were scheduled for December 15, 2025.

On November 20, 2025, we received a request from Representative Eddie Day Pashinski for an in-person public input hearing in Luzerne County.

By email dated December 3, 2025, we alerted the active parties to the legislative request to hold the additional in-person public input hearing. We further alerted the parties that we would have to set a due date for Supplemental Direct Testimony to address testimony provided during the December 18, 2025, public input hearing. We asked the parties to collaborate and to provide to us by December 5, 2025, a proposed date for the submission of Supplemental Direct Testimony.

By In-Person Public Input Hearing Notice issued on December 4, 2025, an in-person public input hearing was scheduled for December 18, 2025, in Wilkes Barre, PA.

By email received on December 5, 2025, Devin Ryan, Esq., Counsel for PPL, informed us that the parties collectively proposed that Tuesday, December 30, 2025, be established as the due date for Supplemental Direct Testimony. As this proposal is reasonable and in direct response to our request, it will be adopted by the ordering paragraphs below.
