ResCom Energy LLC d/b/a NextVolt Energy ("ResCom Energy") is submitting this written notification of certain changes to its corporate information. ResCom Energy is providing this notice in compliance with applicable rules that may require notification of a change to information originally associated with its competitive retail energy supplier license. ResCom Energy underwent a corporate reorganization which resulted in the addition of two new upstream holding companies as illustrated in the attached organizational chart. ResCom Energy is now a wholly owned subsidiary of NextVolt OpCo LLC, which, in turn, is wholly owned by NextVolt Mezz Co LLC. The Power 1 Energy Company ("P1EC"), which was the previous direct owner of ResCom Energy, is the whole and sole owner of NextVolt Mezz Co LLC. These changes have no effect on ResCom Energy's customers, and all customer contracts remain in effect and will continue to be serviced by ResCom Energy LLC d/b/a NextVolt Energy.

In addition to the above reorganization, ResCom Energy has appointed Kelly Bordelon as Senior Vice President of Finance, replacing David Draper, Chief Financial Officer.





