**ORDER REFERRING APPLICATION
FOR MODIFIED PROCEDURE**

On June 10, 2025, First Choice Home & Community Services, Inc. (Applicant) filed an Application for Motor Common Carrier of Persons in Paratransit Service for Approval to “transport, as a common carrier, by motor vehicle, persons in paratransit service, from points in the Counties of Delaware and Montgomery, and the City and County of Philadelphia, to points in Pennsylvania, and return.”

Notice of the Application was provided in the *Pennsylvania Bulletin*, 55 Pa.B. 6666 (September 13, 2025). Protests were due by September 29, 2025.

On September 29, 2025, Bux-Mont Transportation, Inc. (Bux-Mont), Easton Coach Company (Easton), Suburban Transit Network, Inc. (TransNet), and Tri County Transit Service, Inc. (Tri County)(collectively, “Joint Protestants”) filed a timely Joint Protest to the Application.

By Initial In-Person Hearing Notice dated October 6, 2025, an Initial In-Person Hearing in this matter was scheduled for December 10, 2025, and the matter was assigned to me.

On December 10, 2025, the Applicant and the Joint Protestants filed a Restrictive Amendment and Stipulation in which the Joint Protestants agreed to withdraw their Protest to the Application based upon the Restrictive Amendment and its acceptance by the Commission. The
