**ORDER**  
**GRANTING INDEFINITE STAY OF PROCEEDINGS**

Background

On March 5, 2025, Everstream Solutions, LLC (“Everstream”) filed an application to abandon public utility service with the Pennsylvania Public Utility Commission.

On March 24, 2025, Zito Media Communications (“Zito”) filed a Protest to the Abandonment Application.

On April 10, 2025, Everstream filed a response to the Protest of Zito.

Also, on April 10, 2025, T-Mobile USA, Inc. (“T-Mobile”) filed a Protest to the Abandonment Application.

On April 30, 2025, Everstream filed a response to the Protest of T-Mobile.

On August 7, 2025, a Prehearing Conference was held.

On August 18, 2025, Everstream filed a Motion for Summary Judgment (“motion”).

Since approximately September 1, 2025, the parties have mutually requested multiple extensions to answer the motion, via email, to allow the parties to further engage in settlement negotiations. The assigned administrative law judges granted the requested extensions via email responses to the parties.

Based on the last extension, answers to Everstream's motion are due on January 9, 2026.

On December 18, 2025, T-Mobile filed an Unopposed Motion for Indefinite Stay of Proceedings in Furtherance of Settlement and Request to Waive Answer Period ("motion for indefinite stay"). In the motion for indefinite stay, the parties indicate that T-Mobile and Everstream have reached a settlement in principle that provides for the stay of these proceedings. Additionally, T-Mobile requested that the 20-day answer period to the motion for indefinite stay be waived.

In light of the parties' representations that they are working toward a settlement of this matter, as well as the Commission's policy of encouraging settlements in contested proceedings, we will grant T-Mobile's motion for indefinite stay as ordered below.

THEREFORE,

IT IS ORDERED:

1. That the Unopposed Motion For Indefinite Stay Of Proceedings In Furtherance Of Settlement And Request To Waive Answer Period is granted.

2. That the proceeding at Docket No. 2025-3053757 is hereby stayed pending further order.

3. That the parties shall file status updates at 60-day intervals beginning 60 days after the date of entry of this Order.
