Re: Cancellation of Certificate of Public Convenience Docket Nos. A-2019-3007581 (Paratransit), A-2019-3009817 (Group & Party 16+), and 2019-3007406 (Limousine).

To Whom it May Concern:

On October 23, 2025, the Commission entered a Tentative Order, Docket No. M-2025-3057706, which advised Fortune Transportation Group LLC that it was not in compliance with the insurance requirements of 66 Pa.C.S. § 512. The Tentative Order advised Fortune Transportation Group LLC, that it must, within 30 days of publication of the Tentative Order, either have acceptable evidence of insurance filed with the Commission, cancel their authority, or file comments to the Tentative Order. The Tentative Order advised Fortune Transportation Group LLC that, if it failed to respond, its certificate of public convenience would be cancelled. The Tentative Order was served on Fortune Transportation Group LLC and published in the *Pennsylvania Bulletin*.

Fortune Transportation Group LLC failed to respond to the October 23, 2025, Tentative Order and remains in non-compliance with the insurance requirements of the Public Utility Code at 66 Pa.C.S. § 512.

Furthermore, this Commission will request the Pennsylvania Department of Transportation to put an administrative hold on Respondent's vehicle registrations. Respondent will **NOT** be able to register any new vehicles or renew any existing vehicle registrations until a new application for authority is submitted. Additionally, all unpaid fines or assessments accrued while you had authority, are still due.

**YOU ARE ADVISED:** That the certificate(s) issued at Docket Nos. A-2019-3007581, 2019-3009817, and 2019-3007406 be and are hereby *cancelled*, and all rights, powers, and privileges granted thereby shall forthwith cease and terminate. Carrier does not hold an active authority.
