SCHEDULE 4

STANDARD FORM OF AGREEMENT TO BECOME A MEMBER OF THE LLC

Any entity which wishes to become a Member of the LLC shall, pursuant to Section 11.6 of this Agreement, tender to the President an application, upon the acceptance of which it shall execute a supplement to this Agreement in the following form:

Additional Member Agreement

1. This Additional Member Agreement (the 'Supplemental Agreement'), dated as of 12/16/25, is entered into among Digital Power USA, Inc. and the President of the LLC acting on behalf of its Members.

2. Digital Power USA, Inc. has demonstrated that it meets all of the qualifications required of a Member to the Operating Agreement. If expansion of the PJM Region is required to integrate Digital Power USA, Inc. facilities, a copy of Attachment J from the PJM Tariff marked to show changes in the PJM Region boundaries is attached hereto. Digital Power USA, Inc. agrees to pay for all required metering, telemetering and hardware and software appropriate for it to become a member.

3. Digital Power USA, Inc. agrees to be bound by and accepts all the terms of the Operating Agreement as of the above date.

4. Digital Power USA, Inc. hereby gives notice that the name and address of its initial representative to the Members Committee under the Operating Agreement shall be:

5. The President of the LLC is authorized under the Operating Agreement to execute this Supplemental Agreement on behalf of the Members.

6. The Operating Agreement is hereby amended to include Digital Power USA, Inc. as a Member of the LLC thereto, effective as of December 16, 2025, the date the President of the LLC countersigned this Agreement.
