

- 1) Your new application at A-2025-3059386 for Paratransit Service shows different ownership than your previous application. The initial application showed owner as Alhadi B Dinar. The new application for this company shows ownership as Alhadi B Dinar, Sahar A Dinar and Niemat A Ahmed. Before the new application can be processed, you must request approval of the stock transfer (application available on the PA Public Utility Commission website under Ongoing Applications). All changes of ownership can ONLY be accomplished through this formal approval process. Once that has been completed, then the new application for Paratransit Service can be processed.
