NOTIFICATION OF PROPOSED CONSTRUCTION

Pursuant to the requirements of 52 Pa. Code § 59.38, National Fuel Gas Distribution Corporation (“National Fuel”), hereby files the following Notification of Proposed Construction:


1. Description and Location of Proposed Work. National Fuel is planning to install approximately 135’ of 4” and 12,320’ of 6” plastic pipeline in Fairview Township along Laver Rd, Perry Highway and District Rd. The project will be constructed by a National Fuel approved contractor.
2. Type of Facility. Installation of 4” and 6” plastic gas line facilities.
3. Estimated Starting Date. Construction is expected to begin on or about April 6th, 2026.
4. Estimated Completion Date. Construction is expected to be completed by June 26th, 2026.
5. Design Pressure. The pipeline will be designed for a maximum allowable operating pressure of 124 psig.
6. Estimated Cost. The cost of the pipeline project is \$1,131,000.
