**T-MOBILE USA, INC. NOTICE OF WITHDRAWAL PROTEST**

Pursuant to 52 Pa. Code § 5.94(b),<sup>1</sup> T-Mobile USA, Inc. (“T-Mobile”) files this Notice of Withdrawal of Protest to withdraw the protest it filed on April 10, 2025 (“Protest”) opposing Everstream Solutions, LLC (“Everstream”) Application to abandon public utility service (“Application”).

52 Pa. Code § 5.94(b) allows withdrawal of a protest upon the filing of a notice stating the reasons for withdrawal.

T-Mobile withdraws its Protest because it has reached a settlement with Everstream. As of January 5, 2026, T-Mobile is no longer an Everstream customer and thus no longer seeks to protest Everstream’s Application to abandon public utility service in Pennsylvania.

Accordingly, the Protest of T-Mobile to Everstream’s Application is hereby withdrawn.
