Dear Secretary Homsher:

I, Thomas E. Weaver, the Principal Owner of Corner Water Supply & Service Corporation ("Corner Water"), respectfully request, under 52 Pa. Code § 1.82, to withdraw the Petition of Corner Water Supply & Service Corporation for a Waiver of 52 Pa. Code § 65.54 and All Associated Requirements Concerning a Lead Service Line Replacement Program that I filed on February 13, 2025 ("Petition for Waiver").

I am requesting the Petition for Waiver be withdrawn because on November 20, 2025 Corner Water sold its water system to Pennsylvania-American Water Company ("PAWC"). A letter evidencing the completion of the sale (the "Transaction") was filed on November 20, 2025 at Pennsylvania Public Utility Commission ("PUC" or the "Commission") Docket Nos. A-2025-3052745 and A-2025-3052747. The Commission's Order entered on September 2, 2025 at Docket Nos. A-2025-3052745 and A-2025-3052747 indicated at Ordering Paragraph No. 12 that the Commission approved PAWC's right to begin providing water service to the public, and for Corner Water to abandon water service to the public, in portions of Elk and Paint Townships, Clarion County, Pennsylvania that were served by Corner Water. With the completion of the Transaction, all customers previously receiving water service from Corner Water are now served by PAWC.

On July 22, 2024, at PUC Docket No. P-2024-3050263, PAWC filed a Petition for Approval of a Lead Service Line Replacement Program, Related Tariff Changes, and Modification of a Long-Term Infrastructure Improvement Plan ("PAWC LSLR Petition"). On March 31, 2025, a Joint Petition for Approval of Settlement of All Issues ("Settlement") was filed at Docket No. P-2024-3050263 to address the issues in the proceedings concerning the PAWC LSLR Petition. On August 14, 2025, the Commission entered an Order approving the Settlement.

It is in the public interest for the Commission to grant Corner Water's request to withdraw its Petition for Waiver as the customers that were formerly served by Corner Water are now served by PAWC, and are subject to PAWC's Lead Service Line Replacement Program.


