Keystone EasyRide LLC will provide non-emergency medical transportation including ambulatory and wheelchair-accessible services, to and from medical appointments and related healthcare facilities within Blair County and surrounding counties, including Cambria, Centre, Huntington, Clearfield and Bedford Counties.

Examples:

- To transport people whose personal convictions prevent them from owning or operating motor vehicles from points in Lancaster County to points in PA, and return.
- To transport people from the city and county of Philadelphia to correctional facilities in PA, and return.
- To transport people in wheelchair and stretcher vans from points in the city of Pittsburgh to points in Allegheny County, and return.
- To transport people between points in Northumberland County.
