Re: Application of Look Limo LLC for **Limousine** authority, 802 Garret Road, 2nd Floor, Upper Darby, Delaware County, Pennsylvania 1902.

To whom it may concern:

The purpose of this Letter is to advise you that your application for **Limousine** authority at Docket No. A-2025-3059026 has been **DENIED** by the Pennsylvania Public Utility Commission (Commission). The Commission has determined that a Certificate of Public Convenience shall not be granted for the following reason(s):

- **Failure to File Required Information.** A letter dated December 10, 2025, was sent informing you that the Pennsylvania Public Utility Commission required supporting documentation of the applicant's financial position in order to complete the processing of **Look Limo LLC's** application for authority. The letter informed you that failure to submit the required information within ten days would result in dismissal of the application. To date, more than thirty days later, you have not adequately complied with all aspects of that request.

For this reason(s), your application is **DENIED** and **DISMISSED**.

APPEAL RIGHTS

If you disagree with this determination, you may send a Petition for Reconsideration from Staff Action (Petition) to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120. Such a Petition is a written statement asking the Commission to change its determination.

ALL Parties to proceedings pending before the Commission are advised to open and use an e-filing account through the Commission's website, OR you may submit your filing by

overnight delivery. If a filing contains confidential or proprietary material, the filing is required to be submitted by overnight delivery.

The Petition must be filed with the Commission within twenty (20) days of the date of this letter. If no timely request for reconsideration is made, this action will be deemed to be the final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request, (2) the case docket number(s) (they are provided for you at the top right-hand corner of this letter), (3) the name of the person on whose behalf the petition is made, (4) copies of relevant documentation, and (5) a verification with original signature. *See* 52 Pa. Code §§1.31 and 5.44. Below is a sample Verification:


