This filing is for an INCREASE in local hourly rates


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays, 8 hours at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays 6:01PM to 6:00AM: 4 hours at rates named in Columns 1 and 4. Weekdays 6:01AM to 6:00PM: 4 hours at rates named in Columns 1 and 3.

NOTE 5 - Rates named in Column 4 apply only from 6:01PM to 12:00 Midnight on any day when a higher rate is shown for the following day.

NOTE 6 - Carrier will supply and charge for supervisor or supervisors as requested by shipper. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at first point of origin until completion of unloading and dismissal of vehicles and men at final destination unless other time of arrival or dismissal is provided by agreement between shipper and carrier.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps or MapQuest.

0-20 miles	1 hour
21-40 miles	1 1/2 hours
41-60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 20 miles.
