**PHILADELPHIA GAS WORKS' MOTION TO CONTINUE**

1. By notice dated November 19, 2025, the Commission scheduled a hearing in this matter for Tuesday, January 20, 2026 at 10:00 a.m., before Administrative Law Judge Eranda Vero.
