Dear Secretary Homsher:

Enclosed for filing on behalf of American Water Works Company, Inc., Essential Utilities, Inc., Aqua Pennsylvania, Inc., Aqua Pennsylvania Wastewater, Inc., and Peoples Natural Gas Company, LLC (the "Joint Applicants") are additional Proofs of Publication indicating that notice of the above-referenced matter has been published in newspapers of general circulation in the affected area.

Additionally, the Joint Applicants advise the Pennsylvania Public Utility ("Commission") that, during the course of obtaining affidavits of publication from various newspapers, the undersigned counsel was advised by *The Progress-Clearfield* (covering Clearly County) and *The Tribune-Democrat* (covering Somerset County) that these papers did not publish the requisite notices on or before December 29, 2025. The undersigned's office reviewed and approved advertising proofs, confirmed run dates with each of these publishers on December 10, 2025 and December 16, 2025, respectively, and was issued invoices for the same. Moreover, each publisher received, and cashed checks issued for payment of the advertisements, on December 18, 2025 and December 24, 2025, respectively. However, during the course of its outreach to publications requesting affidavits

confirming publication of the notices, each of these publications notified the undersigned's office last week that the advertisements were not published as ordered.

After further investigation, the undersigned was able to confirm that the circulation of the *Indiana Gazette* includes Somerset County. However, no other publication where the advertisement was published covers Clearfield County.

The Joint Applicants note that “[p]ublication in a newspaper of general circulation serving the geographical territory affected by the application” is considered a supplemental form of notice, which the Secretary is afforded discretion to order or not. 52 Pa. Code § 5.14(b). Legal notice of the above-captioned application was completed via publication of notice in the *Pennsylvania Bulletin*, on December 13, 2025. In addition, with respect to Somerset County, a separate publication that circulates in this area contained the requisite notice. The Joint Applicants submit that sufficient notice of the Application has been provided at this time, but will provide additional supplemental notice if and as directed by the Commission.
