Request for Information

1.) Question #4 of the application.

It was indicated your Legal Name (Company Name) is “Trayvond L. Massenburg” and it was registered with the Department of State. An invalid PA Corporation ID # was provided. Correct the Legal Name of the Company on page no: 1 of the application with the correct PA Corporation ID # or explain the discrepancy with the e-filing information indicating the Legal Name is “Transporting Lives Mindfully LLC”.

The Legal Name of the Company is **Transporting Lives Mindfully LLC**, which is the entity registered with the Pennsylvania Department of State. The PA Corporation ID number associated with **Transporting Lives Mindfully LLC** is 14813884 . Page 1 of the application will be corrected to reflect the proper Legal Name and corresponding PA Corporation ID.

2.) Question #10 of the application.

A.) Is it your intention to offer transportation services from points in the City and County of Philadelphia?

Yes. The applicant intends to offer non-emergency medical transportation services from points in the City and County of Philadelphia.

B.) The proposed persons being transported limits your service to non-medical transportation passengers only. Do you wish to broaden your customer base?

Please make corrections with the Commission’s parameters in mind or verify that the example below is what you now intend.

Example: To transport persons, by motor vehicle, in Paratransit service, from points in City and County of Philadelphia, to points in Pennsylvania, and return.

To transport persons, by motor vehicle, in **Paratransit service**, including **non-emergency medical transportation**, from points in the **City and County of Philadelphia**, to points in **Pennsylvania**, and return.

3.) Question #2 Verified Statement.

A statement of ownership is not requested here. We need you to list the Company's relationship with other motor carrier companies here.

Transporting Lives Mindfully LLC **has no ownership interest in, affiliation with, or contractual relationship** with any other motor carrier companies. The applicant is an **independent carrier** and does not share vehicles, drivers, management, dispatch services, or operating authority with any other motor carrier.

4.) Question #4 Verified Statement.

A.) Please include the plan on how you are to secure customers' sensitive information.

Transporting Lives Mindfully LLC will protect all customers' sensitive information by storing records in secure, password-protected systems and locked files, limiting access to authorized staff only. All electronic communications will use encrypted methods, and employees will receive training on privacy and confidentiality. When no longer needed, records will be securely destroyed.

B.) Please respond with a clear description of where your vehicle(s) will be parked in relation to the physical address (Philadelphia PA).

All company vehicles will be parked at the physical address in Philadelphia, PA, in the garage or driveway, when not in use. The parking area is secured and accessible only to authorized personnel, and vehicles will be maintained on-site and ready for operation during business hours.

C.) Please explain the Erie PA mailing and email address. Are these addresses exclusively for Trayvond Massenburg or that of a third-party consultant assisting with the application?

Transporting Lives Mindfully LLC uses a registered agent for all official correspondence. All Commission communications should be directed to the registered agent's address on file with the Pennsylvania Department of State. The company's primary business operations and vehicles are located in Philadelphia, PA. My personal Mailing address is 413 w Cayuga st. Philadelphia PA. 19140.

If the address is not your own, then you must remove it from our record and provide us with an alternative mailing address.

- **Note:** Only attorneys will be added to Commission records, third party consultants will not, and refrain from adding their information to our paperwork.

5.) Question # 5 Verified Statement. Please reference the requirement of Title 52 of the

Pennsylvania Code § 29.503, Code § 29.504 and Code § 29.504 which may be accessed at

www.pacode.com. This is not optional.

Transporting Lives Mindfully LLC will comply with Title 52, Pennsylvania Code §§ 29.503 and 29.504. All drivers will hold a valid driver's license, meet age requirements, and have their driving history reviewed before and during employment as required. These regulations are available at www.pacode.com, and the company will maintain compliance at all times.

A.) You need to provide a compliant ongoing plan for reviewing after the mentioned

initial hiring check, for both the driver's licenses and criminal history.

Transporting Lives Mindfully LLC will maintain an ongoing compliance plan for all drivers. Driver licenses and criminal histories will be reviewed annually and updated as necessary. Any issues affecting eligibility to operate will be addressed immediately, and records of all reviews will be maintained on file for Commission inspection.

B.) Please include your minimum hiring age requirement for drivers.

Transporting Lives Mindfully LLC requires that all drivers be at least 18 years of age at the time of hire. Drivers under 21 will only operate in accordance with PUC regulations and any applicable restrictions for paratransit service.

C.) Finally, you must explain your policy regarding your driver training program

beyond saying that only will be offered and completed. Furnish the program on

separate pages and attach it to your reply to us.

Transporting Lives Mindfully LLC provides a comprehensive driver training program covering: vehicle safety, passenger assistance (including mobility challenges), non-emergency medical transport procedures, privacy, and compliance with PUC regulations (Title 52 §§ 29.503 and 29.504). Training includes initial and ongoing refresher sessions. A detailed program outline is furnished on separate pages and attached to this reply.

6.) Question #7 of the Verified Statement.

Provide an explanation of what the trip inspections will encompass. Submit documents that

might be used for these daily inspections.

Transporting Lives Mindfully LLC will perform daily vehicle inspections before trips. Inspections include brakes, lights, tires, fluid levels, emergency equipment, passenger safety devices, and overall vehicle condition. Drivers will complete a daily inspection checklist, which is furnished on separate pages and attached to this reply.

7.) Your Statement of Financial Position (Balance Sheet) was omitted. This is unacceptable.

- A.) You are required to provide a dated balance and complete sheet. This is not an option. It is expected that the company is fully funded and ready to commence operations. The Commission will need to determine that you have financial capabilities to run a safe, efficient, and reliable transportation operation. If you are unable to provide a compliant balance sheet, your application will be denied, as per 52 Pa. Code §41.14. It is the responsibility of the applicant seeking motor common carrier authority to demonstrate that it possesses the financial ability to provide the proposed service. Any assets which may need transferred to the applicant should happen prior to adding them to the completed balance sheet.
- B.) To fully assist the Commission in determining financial fitness please submit copies of the claimed vehicles' registrations or titles and a copy of a recent bank account statement ALL in the name of the Company. The bank statement(s) account numbers may be redacted. If you may choose to submit a notarized/official statement(s) of the Companies' finances provided by bank officers. Please make sure their contact information is current.

Note: It is in your best interest to provide accurate, complete, and timely responses. Be advised that additional corrections may not always be requested; therefore, prior to submitting your responses, your consultation with an attorney or financial expert familiar with Commission regulated Motor Carrier related proceedings is highly encouraged.



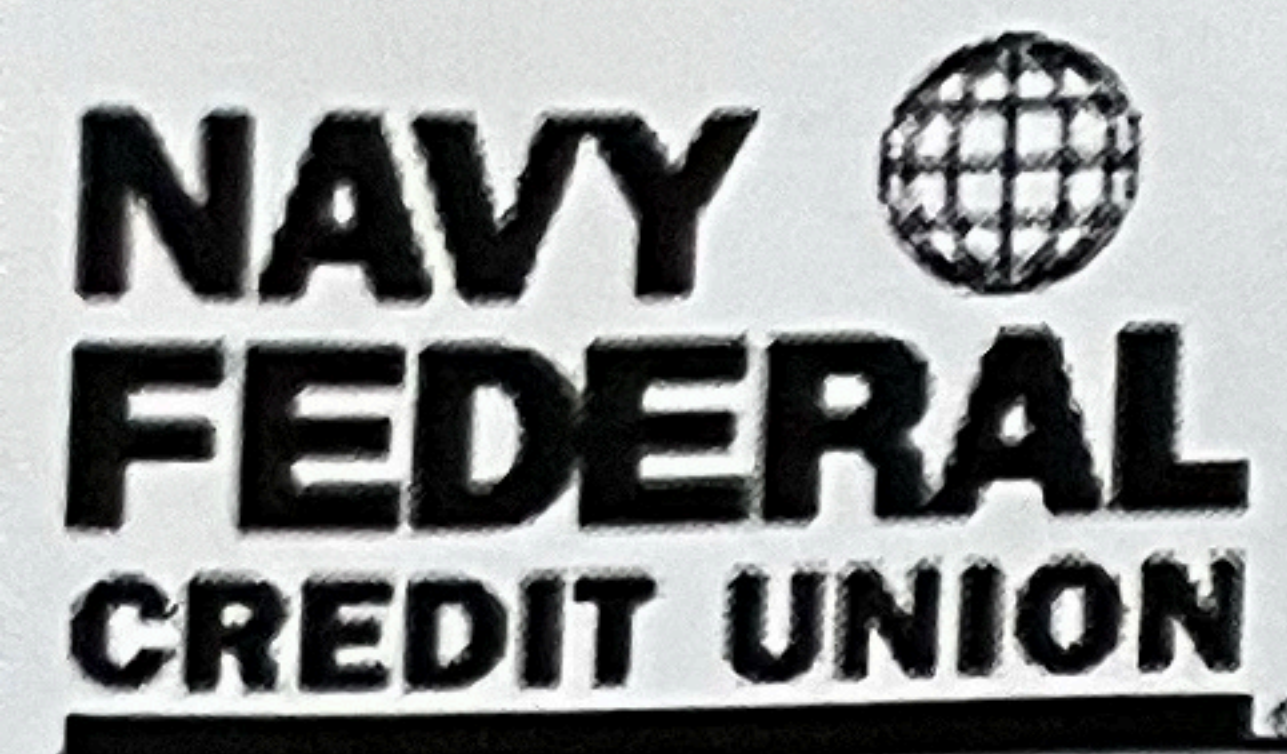
