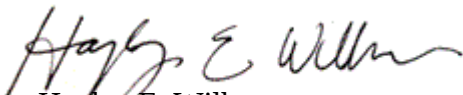

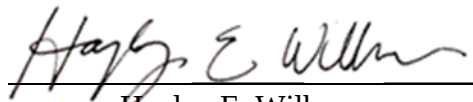

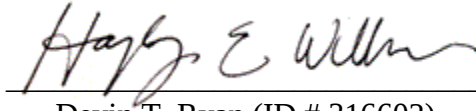
CERTIFICATE OF SATISFACTION
