Columbia Gas of Pennsylvania, Inc. (“Columbia”) files this letter to supplement its October 1, 2025 Notification.

Pursuant to Ordering Paragraph No. 1 of **the Public Utility Commission’s July 12, 1977 Order**, Columbia submits that the customer located at 56 Prestley Road, Bridgeville, Pennsylvania, was transferred to Peoples on January 14, 2026, **due to the “elimination of duplication of facilities.”** Columbia first notified the customer of the proposal to transfer their gas service to Peoples’ facilities on April 22, 2025. The customer did not object to the transfer.

Peoples was advised of the October 1, 2025 Notification. I am copying counsel for Peoples on this supplemental Notification as well.
