Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, effective February 23rd, 2026, for On-Point Movers, LLC (PA PUC Certificate #A-8928006) in Johnstown PA.

This filing is for an **INCREASE** on the local hourly rates for the vehicle on Holidays, Monday-Friday and Saturdays & Sundays and the driver Monday-Friday. Carrier requests a **REDUCTION** on the local hourly rates for additional men on Holidays, Monday-Friday and Saturdays & Sundays, a **CHANGE** in the minimum transportation charge on local moves to three (3) hours plus the applicable travel time charge, and a **CHANGE** in the application of travel time charges.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 5 - When for the convenience of the customer, shipment is held overnight, the carrier will assess a holding fee of \$300.00 per truck per night.

▲ NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 30 miles	1/2 hour
31 - 60 miles	1 hour

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 30 miles.
