This filing is for the **ADDITION** of rental container rates TV & wardrobe cartons. All other rates in this carrier's exceptions remain the same.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour periods; fractions of one-quarter hour considered as one-quarter hour.

NOTE 4 - Minimum Transportation Charge: Sundays & Holidays (any hour): 8 hours at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays (6:01PM to 5:59AM): 4 hours at rates named in Columns 1 and 4. Weekdays (6:00AM to 6:00PM): 4 hours at rates named in Columns 1 and 3.

NOTE 5 - In lieu of applicable packing/unpacking rates by county in tariffs, Tristate 50-T & Tristate 51-W, Schedule D rates will be used for packing & unpacking labor anywhere within Pennsylvania.

NOTE 6 - When carrier sends more than three (3) men on a local move (shipment transported 40 miles or less), an additional flat fee of **\$50.00** per Passenger/Transport vehicle will apply.

▲ NOTE 7 - When requested by customer, in lieu of published rates for containers in Tristate 50-T and Tristate 51-W, carrier will provide a TV carton at a rental cost of **\$25.00** per carton and a wardrobe carton at a rental cost of **\$5.00** per carton. Cartons are to be unpacked and returned to the carrier at completion of the move. The rental charge applies to shipments transported 40 miles or less and in excess of forty miles.

NOTE 8 - In lieu of application and charges shown for Full Value Protection in tariffs, Tristate 50-T & Tristate 51-W, the following will apply for this carrier: Coverage amount to be computed at estimated weight multiplied by \$6.00 per pound. Rates are as follows:

FULL VALUE PROTECTION WITH \$0.00 DEDUCTIBLE: \$5.00 PER \$1,000.00 OF COVERAGE

FULL VALUE PROTECTION WITH \$250.00 DEDUCTIBLE: \$4.25 PER \$1,000.00 OF COVERAGE

FULL VALUE PROTECTION WITH \$500.00 DEDUCTIBLE: \$3.50 PER \$1,000.00 OF COVERAGE

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 30 miles	1 hour
31 - 60 miles	2 hours

For mileage in excess of 60 miles, travel time charge will be assessed based on actual travel time.

NOTE 10 - STORAGE-IN-TRANSIT AND WAREHOUSE HANDLING CHARGES (Item 200 and Section 3) - Rates shown for Allegheny County will apply for all counties in Pennsylvania when storage-in-transit is at the carrier's facility in Warrendale PA.

NOTE 11 - EXTRA PICKUP AND/OR DELIVERY (Item 230) - Rates shown under Schedule E will apply for all counties in Pennsylvania.
