Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, effective February 23rd, 2026, for L & J Transportation Companies, Inc. (PA PUC Certificate #A-00109787) in Pottstown PA.

The attached pages are 741st Revised Page 2, 108th Revised Page 2-C, 6th Revised Page 63-E, 3rd Revised Page 63-E-1, and 3rd Revised Page 63-E-2.

This filing is for an **INCREASE** in local hourly rates (both Non-Peak Season and Peak Season), an **INCREASE** in labor rates & the additional transportation charge for shipments transported in excess of 40 miles, an **INCREASE** in premiums for Full-Value Protection coverage, and a **CHANGE** in the minimum coverage for Full-Value Protection.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 1 - Minimum Transportation Charge: Sundays and Holidays (Any Hour): 8 hours at rates named in Column 2 plus applicable traveling charge. Saturdays and Weekdays (Any Hour): 4 hours at rates named in Columns 3 or 4 plus applicable traveling charge.

NOTE AA - For shipments transported between points in Pennsylvania, the following travel charges will apply when distance from:

- (1) Origin and destination is within 10 air miles of carrier's terminal - 1/2 hour at the applicable rates
- (2) Origin and destination is between 11 and 20 air miles of carrier's terminal - 1 hour at the applicable rates
- (3) Origin and destination is between 21 and 30 air miles of carrier's terminal - 1 1/2 hours at the applicable rates
- (4) Origin and destination is between 31 and 40 air miles of carrier's terminal - 2 hours at the applicable rates
- (5) For mileage over 40 miles, a traveling charge of 1/2 hour per 10 air miles at the applicable rates will be assessed

In lieu of the applicable rates provided in Tariff Freight PA. P.U.C. Nos. 50-T and 51-W, the following rates shall apply:

Tariff 50-T, Item 301 - PK/UNPK - Schedule D Tariff 51-W, Item 110 - PK/UNPK - Schedule D

In lieu of the applicable rates provided for in Tariff Freight PA. P.U.C. No. 51-W, the following rates shall apply:

NOTE 1 - MINIMUM WEIGHT CHARGE (Rule 33) - The minimum weight for all shipments will be 4,000 pounds.

◆ NOTE 2 - LABOR RATE (Item 120) - Labor Rate will be **\$55.00** per man per hour (REGULAR RATES) and **\$80.00** per man per hour (OVERTIME RATES) for all counties in Pennsylvania, regardless of in which county labor is performed.

◆ NOTE 3 - ADDITIONAL TRANSPORTATION CHARGE (Item 160) - An additional fee of **\$5.70** per 100 pounds will apply at both origin and destination for all counties in Pennsylvania, regardless of in which county shipment originates or is destined.

NOTE 4 - STORAGE-IN-TRANSIT AND WAREHOUSE HANDLING CHARGES (Item 200) - Rates shown in Item 101 for **Chester County** will apply for all counties in Pennsylvania, regardless of in which county storage services are performed.

NOTE 5 - EXTRA PICKUP AND/OR DELIVERY (Item 230) - Rates shown under **Schedule E** will apply for all counties in Pennsylvania, regardless of in which county Extra Pickup or Delivery occurs.

The following exception will apply for shipments transported 40 miles or less and in excess of 40 miles:

CONVENIENCE FEE

Carrier will add a **2.5%** convenience fee to the final charges when the customer chooses to pay with a credit card.
