**Enclosed, please find a copy of the Power of Attorney and initial tariff exceptions for T7 Moving and Transportation LTD. (PA PUC Certificate #A-8925832 - A-2025-3058205) in Pottstown PA with an Effective Date of January 22<sup>nd</sup>, 2026 attached to this email.**

The purpose of these changes is a change in service area from a limited territory to "between points in Pennsylvania." This mover is a member of Tristate Household Goods Tariff Conference, Inc. subscribing to the Tristate tariffs, Tristate 50-T (local moves), Tristate 51-W (intrastate moves) and Tristate 54 (exceptions).



In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported forty (40) miles or less.

Subject to Notes 1 to 4 below, the hourly charges are portal to portal based on the travel time from carrier's terminal to the first point of origin, continuing during all loading, transportation from the first point of origin, as well as any extra stops, to the final destination, unloading and dismissal of vehicle and moving crew at the final destination) and the return from the final destination to the carrier's terminal. For the convenience of the customer and the carrier, the travel time from the final destination back to the carrier's terminal may be calculated using a software package designed to calculate mileage and travel time, such as, Google Maps, MapQuest or TruckRouter.

NOTE 2 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour periods; fractions of one-quarter hour considered as one-quarter hour.

▲ NOTE 3 - MINIMUM TRANSPORTATION CHARGE: Any Day (Any Hour): 3 hours at rates named in Column 2, 3 or 4 plus a flat vehicle charge of \$150.00 for a vehicle up to 16 feet in length and \$190.00 for a vehicle in excess of 16 feet in length. When an additional vehicle is needed for the move, an additional flat vehicle charge of \$150.00 for a vehicle up to 16 feet in length and \$190.00 for a vehicle in excess of 16 feet in length plus an extra \$10.00 per hour will be added to the hourly rates shown on Page 98-A.
