You are directed upon receipt of this letter to publish the enclosed notice once a week for two consecutive weeks in a newspaper having a general circulation in the area involved and file proof of publication with the Commission on or before February 23, 2026.

Pursuant to 52 Pa. Code §5.14, the Commission will proceed with publishing the attached notice in the Pennsylvania Bulletin. This notice will appear in the February 7, 2026, issue.


