Dear Secretary Homsher:

Pennsylvania-American Water Company (“PAWC”) respectfully requests a 30-day extension to Answer the Formal Complaint filed by Timothy Hofrichter (“Complainant”) in the above-referenced proceeding. PAWC was served with the Complaint on January 16, 2026. The regulatory deadline for filing responsive pleadings is 20 days, making PAWC’s responsive pleadings due on or before February 5, 2026. *See* 52 Pa. Code § 5.61(a).

PAWC believes a 30-day extension is necessary to accommodate further fact finding related to the allegations in the Complaint, as well as to allow PAWC and the Complainant to pursue further settlement discussions. PAWC has discussed this request with the Complainant and understands that the Complainant does not object to the requested extension. If the extension is granted, PAWC will file and serve responsive pleadings to the Complaint on or before March 9, 2026, if this matter remains unresolved.


